Dear 6<sup>th</sup> Grade Parents/Guardians,

All BELL Academy Students and Staff will have access to an email address <u>@thebellacademy.com</u> which is connected to Google Classroom. This allows students to begin working on a document in school and seamlessly continue working on it at home, or at the library.

As with any educational endeavor, a strong partnership with families is essential to a successful experience. With this letter we are sharing information regarding the use of Google Apps for Education at BELL Academy and are requesting your parental permission for your middle school student to use Google Apps.

The following services are available to each student and hosted by Google as part of BELL Academy's online presence in Google Apps for Education:

- **Docs**: a word processing, spreadsheet, drawing, and presentation toolset that is very similar to Microsoft Office.
- **Calendar**: an individual calendar providing the ability to organize schedules, daily activities, and assignments.
- **Classroom**: a paperless platform for receiving and handing in assignments.
- Mail: an individual internal email account for <u>school use</u>.

Using these tools, students collaboratively create, edit, and share files for school related projects and communicate via email with other students and teachers. These services are entirely online and available 24/7 from any Internet connected computer. Examples of student use include showcasing class projects, building an electronic portfolio of school learning experiences, and working in small groups on presentations to share with others.

Google Apps for Education use at BELL Academy is governed by federal laws and policies including:

• Family Educational Rights and Privacy Act (FERPA)

FERPA protects the privacy of student education records and gives parents the rights to review student records. Under FERPA, schools may disclose directory information but parents may request the school not disclose this information. Parents are provided the opportunity annually to opt out of disclosing their student's directory information on the District's Enrollment Form. FERPA: http://www.ed.gov/policy/gen/guid/fpco/ferpa

• Children's Online Privacy Protection Act (COPPA)

COPPA applies to commercial companies and limits their ability to collect personal information from children under 13. No personal student information is collected by Google for commercial purposes.

This permission form allows the school to act as an agent for parents in the collection of information within the school context.

The school's use of student information is solely for education purposes. Student information that is "collected" by Google is described as (projects, documents, email, files, username and password). COPPA - <u>http://www.ftc.gov/privacy/coppafaqs.shtm</u>
